Tokyo formulates a Climate Change Strategy

A Basic plan for "10-Year Project for a Carbon-Minus Tokyo"

Tokyo Metropolitan Government (TMG) promotes "10-Year Project for a Carbon-Minus Tokyo" as one of the measures aiming for the realization of "Tokyo's Big Change ~ The 10-year Plan ~" formulated in last December. Today, TMG announces that Tokyo Climate Change Strategy was formulated as a basic plan for the 10-Year Project. This strategy clarifies Tokyo's basic posture on climate change in the next decade and poses leading measures. Tokyo formulated this strategy in order to pose leading measures instead of the national government, which is not able to raise effective and workable plans, and take the lead in climate change action in Japan.

Climate change is the most serious environmental problem caused by human activity. In order to avoid dangerous climate change for human beings, CO2 emissions in the world would need to shift to a downward trend between 2015 and 2020. Climate change action in the next decade is crucial.

TMG will have active discussions about the measures posed in the Climate Change Strategy by holding stakeholder meetings with residents, NGOs and companies and promote the measures by means of collaboration and agreement with various people and organizations and constitution of ordinance.

Main points of a Climate Change Strategy

- > Create a system that can make the best use of **environmental technology** in Japan to reduce CO2.
- > Create a system, which each sector, such as large companies, medium and small companies and households, reduces CO2 emissions commensurate with each role and responsibility.
- Focus on the first 3-4 years as the period of transition to the Low Carbon Society and implement the measures strategically and intensively.
- Make a bold investment using private fund, the "Fund to Promote Measures against Climate Change" and tax system etc., if it is needed.

Five policies and major measures

1, Advance CO2 reduction measures by companies powerfully

- Introduce cap and trading scheme targeting large-scale CO2 emitters.
- Promote energy conservation measures by medium and small companies by means of introducing "Environmental CBO" etc.
- Request financial institutions to expand environmental investments and loans and announce the actual performance of the investment.

2, Adopt a serious stance on the reduction of CO2 emissions from households

- Wipe out the use of incandescent lamps in households.
- Spread photovoltaic generations and high-efficiency energy-saving equipments and revitalize solar thermal market.

3, Create rules for the urban development in order to reduce CO2 emissions

- Formulate the world-leading energy efficiency design specification for the buildings and apply it to all city-owned buildings.
- Obligate large scale buildings to meet certain energy efficiency performance.

4, Promote the reduction of CO2 emissions from automobile traffic

- Create rules for the utilization of fuel-efficient automobiles in order to expand the use of hybrid cars.
- Develop environmental automobile fuel promotion project.
- Create a system, which assists voluntary activities by private companies such as Eco-Driving Campaign.

5, Create Tokyo's unique system, which assists each sector's CO2 emission reduction actions

- Develop an energy efficiency promotion program to assist the energy efficiency actions by medium and small companies and households.
- Examine the introduction of Tokyo's own "Energy Efficiency Promotion Tax System".
